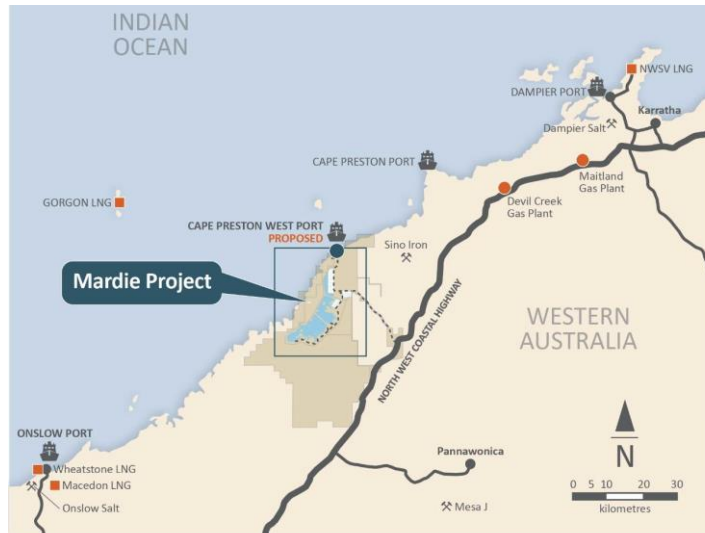


## MARDIE SALT AND POTASH PROJECT

### EXPRESSION OF INTEREST

**Project Overview:**

The proposed Mardie Salt & Potash Project (**Project**) is located within Australia’s major salt producing region on the West Pilbara coast. The Project is proposing to be Australia’s first to produce salt and Sulphate of Potash (**SOP**) through the evaporation of seawater.

**Package Title:**

Site Wide Control Systems

**Package Description:**

The Scope of Work covers to provision of labour, plant and equipment, materials, management, supervision and testing necessary to carry out the construction and installation of the Plant wide Process Control system (PCS).

**Specific Scope Requirements:**

Contractors wishing to be considered must be able to demonstrate their ability to complete the following tasks:

- PCS hardware and software development and verification;
- PCS SCADA / HMI interface with all Vendor packages within the Project;
  - Mardie Project Vendor / Supplier packages include:
    - Transshipping and Product Handling Facilities;
    - Sulphate of Potash (SOP) Processing Plant;
    - Salt Wash Processing Plant;
    - Remote Pumping and Transfer Stations (x3);
    - Power Generation Station;
    - Microwave / telemetry systems; and
    - CCTV systems.
- Configuration and integration to corporate business systems;
- SCADA / HMI configuration and integrated real time monitoring and control; and
- Commissioning and performance verification.

Exclusions from the Scope of Works:

- Vendor package PCS and communications equipment design and supply.
