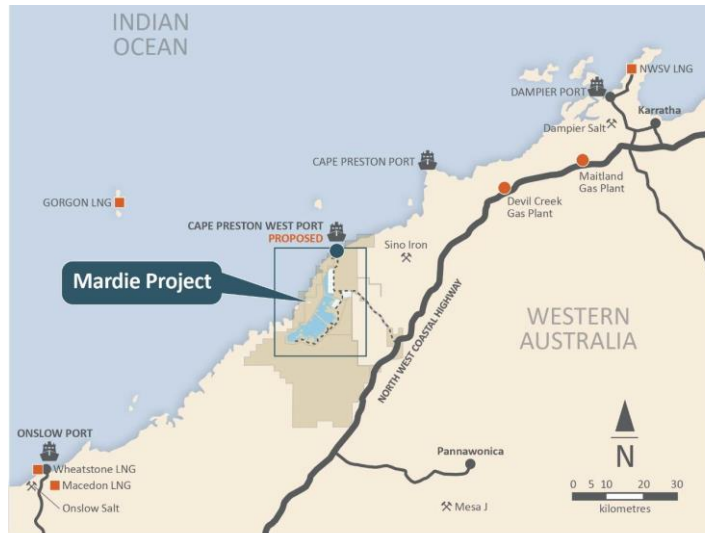


## MARDIE SALT AND POTASH PROJECT

### EXPRESSION OF INTEREST

**Project Overview:**

The proposed Mardie Salt & Potash Project (**Project**) is located within Australia’s major salt producing region on the West Pilbara coast. The Project is proposing to be Australia’s first to produce salt and Sulphate of Potash (**SOP**) through the evaporation of seawater.

**Package Title:**

Village Catering and Maintenance

**Package Description:**

The Scope of Work covers to of all management, labour, tools, equipment, materials, consumables and any other items necessary for camp management, catering services and maintenance for a 402-person village (**Mardie Village**).

**Specific Scope Requirements:**

Contractors wishing to be considered must be able to demonstrate their ability to complete the following tasks:

Village Catering

- Management of camp day to day activities including resident bookings and general camp management requirements;
- Provision for all foodstuffs and other consumables necessary to provide meal services in accordance with approved menus and meal requirements;
- Provision for cooking hardware, utensils, dinnerware, flatware and kitchen consumables;
- Provision and management for janitorial, laundry, cleaning and housekeeping services;
- Provision for health and lifestyle services, including recreation and other functions;
- Provision for grease disposal;
- Provision for rubbish collection and disposal;
- Provision for pest control;
- Provision for 24/7 security: and
- Provision for onsite transportation;

Village Maintenance

- Provision for maintenance personnel for the mechanical, electrical and plumbing requirements associated with the Mardie Village (inclusive of administration buildings, accommodation units, staff quarters, kitchen, wet mess, laundries, ice rooms and social facilities buildings); and
- Provision for grounds and landscaping.
